Dear Member -

<u>C.P.I. Adjustment</u>: The Consumer Price Index rose some 9.2% for the four quarters ending 31 March. The increase in our superannuation which will take effect on the first payday in July should be about that figure.

For those interested in the C.P.I. - just what it is, how it is measured and where, I suggest you call into, phone or write the Bureau of Statistics. There is an office in every capital city, the people are very helpful and there are pamphlets and figures about the C.P.I. readily available.

YOUR COMMITTEE is looking at various matters apart from particular ones raised by individual Members. These include monitoring any developments arising from the evernment's intention to discontinue the C.P.I. rise in wages by 2% - i.e. from 9.2% to 7.2%. There is some talk - and that's all it is at the moment - that pensions may be discounted as well as wages.

Also:

- looking at the possible benefits of affiliating with the Retired Persons Federation of Australia, which is a national coordinating body for some 23 organisations of pensioners, superannuants and retired persons;
- exploring what can be done to overcome "fiscal creep" the erosion of the purchasing power of our superannuation. One possibility may be indexation of the income tax barriers - this would at least help Members who find that the C.P.I. rise puts them into a higher tax bracket.

REVIEW OF SUPERANNUATION DECISIONS

The Commissioner for Superannuation has supplied the following for the information of members:-

The initial or original decision affecting a person's superannuation rights is usually made by the Commissioner for Superannuation. A person affected by the original decision who is dissatisfied with the decision has a right under Section 54 of the Papua New Guinea (Staffing Assistance) Act 1973 or Regulation 8B of the Papua New Guinea (Staffing Assistance) (Superannuation) Regulations, depending whether the decision was made pursuant to the Act or the Regulations, to request that the decision be considered by the Commissioner. It is the practice of the Commissioner's Office to inform a person of this right if the decision is considered unfavourable to the person.

A request for reconsideration must be in writing and include the reasons for making the request. The legislation requires the request to be made within thirty days of the date of receipt of advice of the decision unless the Commissioner allows an extension of time.

The reconsideration process involves a comprehensive investigation of all aspects of the case by officers not associated with the original decision. On completion of this investigation the Commissioner reconsiders the original decision and may confirm or revoke the decision or may vary it as he thinks fit.

When informing a person of the result of his reconsideration the Commissioner also provides his reasons. If the result is unfavourable to the person information is provided about the right to seek a review by the Administrative Appeals Tribunal. Only original decisions that have been reconsidered by the Commissioner can be reviewed by the Tribunal.

The following table sets out the steps listed in the foregoing paragraphs:

- . Decision of the Commissioner for Superannuation
- . Advice to the Person of the Commissioner's Decision
- Person may within 30 days of receipt of advice or within such further period as the Commissioner allows, request reconsideration by the Commissioner for Superannuation
- . Request for Reconsideration made
- Comprehensive investigation by officers in the Australian Government Retirement Benefits Office not associated with the original decision
- . Reconsideration of decision by the Commissioner who may confirm revoke or vary the original decision
- . Advice to the person of Commissioner's decision together with reasons
- . Administrative Appeals Tribunal
- . Federal Court
- . High Court.

MINUTES OF THE SPECIAL GENERAL MEETING OF R.O.A.P.N.G. HELD AT THE MANDARIN CLUB, SYDNEY ON 20 APRIL, 1986

The Meeting opened at 10.55 a.m. with 46 Members present.

All apologies received are noted in the Minutes of the 35th Annual General Meeting which immediately followed this Meeting.

The President, Mr Marsh, asked how the Meeting wished to discuss the proposed amendments to the Constitution as printed in the Notice of Special General Meeting. 'r Rudge suggested that the first three points could be dealt with together and the fourth separately. There was general agreement to this.

The President explained that points (a) and (b) were designed to give Associate Members a stronger voice in the Association whilst still safeguarding the rights of Members. Point (c) was designed to overcome any doubts as to the Association's right to elect Patrons.

Mr Les Williams then formally moved that Clauses 6 and 10 of the Constitution of the Association be amended as follows: (seconded by Mr Rudge)

- (a) Amend Clause 6 (j) by deleting '25%' and substituting '30%'.
- (b) Amend Clause 10(b) by deleting 'but may submit resolutions' and substituting 'on any matter affecting superannuation or superannuants but otherwise shall be eligible to vote and submit resolutions'.
- (c) Insert a new Clause 10A as follows: 10A. The Association may, at an Annual or Special General Meeting, appoint one or more Patrons'.

Mr Clifton-Bassett asked whether the aim of point (a) was to raise the percentage of Associate Members on the Committee or the percentage in the Association as a whole. Mr Parrish explained that the amendment referred to the Committee. The present mit of 25 per cent had been exceeded all last year by two or three percent. The amendment would legalise this situation and give Associates a better representation.

There being no further discussion the motion was carried.

The President then turned to point (d), explaining that in view of the expanding amount of work of sub-committees, it was desirable to formalise their authority.

Mr Burfoot moved, seconded by Mr Kaad, that Clause 6 of the Constitution of the Association should be amended by adding "(k) The Committee shall have power to delegate (subject to such conditions as it thinks fit) any of its powers to sub-committees consisting of such members of the Committee and other members of the Association co-opted for that purpose as it may determine and to make such regulations as to the proceedings of such sub-committees as may be considered desirable".

Mr Kimmorley said that all organisations working through subordinate groups needed some such clause. He felt that the wording was suitable but asked whether it varied from that normally used. Mr Parrish replied that it followed general usage and had been drafted by Mr Clay.

There being no further discussion the motion was then carried.

The Minutes of the 34th AGM which had been published in "Una Voce" were confirmed on the motion proposed by Mr Seale, seconded by Mr Clout.

The President welcomed all present, including wives and friends. A special welcome was given to country and interstate visitors and our guests from the PNG Consulate and the PNG Club. After informing late-comers that the Special General Meeting had endorsed the proposed changes to the Constitution, as set out in the Notice of that Meeting, the President went on to present his report for the year. In summary, he said that to meet the changing and increasing needs of Members and make the work of the executive officers - particularly the Treasurer - less onerous, five sub-committees had been formed and the chairperson of each would shortly say a few words. However, he would strongly commend the Keep in Touch (KIT) Sub-Committee which has received a very favourable response from the members it has contacted. It would be a wonderful thing if similar groups, formal or informal, could be set up wherever there are few ex-Territorians.

We hope to develop further our friendship with the PNG Club and perhaps arrange an extra lunch, harbour cruise or some other social activity. Any suggestions would be welcomed.

We are also strengthening our ties with the Superannuated Commonwealth Officers' Association (SCOA) whose executive is always ready with information and advice. In the possibly difficult times ahead we may need all the friends we can get.

The 9.2% rise in superannuation payments in July will be most welcome and we are grateful that we are not on fixed incomes. However those in the higher tax bracket will have realised that the nett value of the rise is a long way from covering the true cost of living increase.

The President went on to thank the members of the Executive Committee and the Sub-Committees for the excellent job they have done, as he believed that with their help the Association was developing in a way which will make it more meaningful to us all-

In closing, the President said " I would again thank you all for coming here today. We are a group with memories of work and play shared in Papua New Guinea, memories which far exceed the usual experiences of those who have worked only in Australia. I believe these are something we should cherish."

The President then asked the chairpersons of each Sub-Committee to briefly say something of its activities.

Mr Speer spoke of the work of the Keep in Touch committee contacting Members or their spouses in hospital, by home visits or merely by telephoning. The KIT committee did not want to intrude on anyone's privacy, but rather to offer friendship, advice or other help. For instance, some Christmas cards were sent out to older Members and widows and the response had proved them well worthwhile. The many visits made and the variety of assistance provided had provedthe need for such a service.

Mr Parrish said that the Legal and Administrative Sub-Committee had been formed to follow up any queries of this nature raised by Members or the Committee. These had included complaints of delays in receiving cheques and requests for advice on how to proceed with requests and appeals.

Mr Burfoot said that the Social and Membership Sub-Committees had only recently been formed, with the aims of strengthening our membership, including Associates. and arranging the social side of the AGM and Christmas luncheons. It would al tryto ascertain the feelings of members about the nature and number of extra functions, if any.

Mr Kaad said that the Editorial Sub-Committee had been formed to try to get more news material, to proof-read and generally help to print, wrap and mail the Newsletter. He thanked Mrs Foley for her help in preparing 'Una Voce' and Mr and Mrs Clout for getting it printed and posted. He then repeated his request to Members for more news items.

Mr Nitsche proposed that the President's Report be received. This was seconded by Mr Clout, and carried.

The Treasurer (Mr Keleny) presented a summary of the detailed Financial Report which had been circulated to Members via the March Newsletter. He quoted membership statistics for the benefit of the Meeting, and acknowledged several donations.

It was proposed by Mr Keleny and seconded by Mr Les Williams that the Treasurer's Report be accepted, and carried.

In speaking to the motion, Mr Seale complimented Mr Keleny on the detailed and precise manner in which he performed the function of Treasurer and presented his Report, a view which was endorsed by all present.

The Election of Office-Bearers followed, and scrutineers were appointed. Mr Marsh advised that he would not be available for nomination, and as there had been no other nominations for President of the Association, Mr Doug Parrish was duly elected.

Before proceeding with further elections Mr Parrish moved a vote of thanks for Mr Marsh, noting that he had been a dedicated President, responsible for a number of new initiatives. This was carried with applause.

REPRINTED CONSEQUENT UPON ANNUAL GENERAL MEETING 1986

THE RETIRED OFFICERS' ASSOCIATION OF PAPUA NEW GUINEA

CONSTITUTION

NAME

1. The name of the Association shall be:

"Retired Officers' Association of Papua New Guinea".

The motto shall be "U N A V O C E"

INTERPRETATION

1A. In this Constitution, unless the contrary intention appears:

"Association" means Retired Officers' Association of Papua New Guinea;

"Associate Member" means a person described in Clause 4(a)(2) who has been admitted to membership of the Association;

"Committee" means the Executive Committee referred to in Clause 6(b);

"Former Services" means the previous public services in Papua New Guinea established by or under:

- (i) the Papua Act 1905 and the Public Service Ordinance 1907 (Papua),
- (ii) The New Guinea Act 1920 and the Public Service Ordinance 1922 (New Guinea),
- (iii) the Papua New Guinea Provisional Administration Act 1945, and the Public Service Ordinance 1949, and
- (iv) the Papua New Guinea Act 1949 and the Public Service (Papua and New Guinea) Ordinance 1963;

"Member means a person described in Clause 4(a)(1) who has been admitted to membership of the Association;

"Office Bearers" means the members of the Committee referred to in Clause 6(c);

"Officer" means an officer of one of the former services;

"Retired Officer" means a former officer who has retired from one of the former services and is entitled to a pension consequent upon such retirement;

"Statutory authority" means a body (other than a public company) established by or under a law of Papua New Guinea (including the Police Force).

References herein to Acts are to Acts of the Commonwealth of Australia as amended from time to time.

HEADQUARTERS 2. The Association's headquarters shall be in Sydney, or as the Annual General Meeting decides.

OBJECTS 3. The objects of the Association shall be:

- (a) to safeguard and foster the retirement conditions of all members, including conditions applicable to widows and dependants;
- (b) to promote friendly association among all former officers;
- (c) to act on behalf of members, their widows and dependants, either collectively or individually, in negotiations with the Commissioner for Superannuation and such other Commonwealth, State or other authorities and organisations whatsoever, in any or all matters affecting the interests of the said members, their widows and dependants;
- (d) to co-operate on all matters of mutual interest with associations representing other pensioners or superannuants (e.g. superannuants of the Commonwealth Public Service) having similar objectives;
- (e) to assist members to establish themselves in Australia and to advise them in social, legal, medical or other problem they may have.

MEMBERSHIP 4. (a) Membership of the Association shall consist of the following categories:

- Member a retired officer or widow or dependant of a deceased officer entitled to pension as a result of the officer's service in one of the former services;
- (2) Associate Member a former officer (other than a retired officer) of one of the former services, of one of the statutory authorities or of the Australian Staffing Assistance Group consitituted by the Papua New Guinea (Staffing Assistance) Act 1973, who terminated his

services by processes not conferring pension rights, or a former resident of Papua New Guinea expressing an interest in the objects of the Association.

- (b) A person eligible for membership, under Clause 4(a), shall lodge an application with the Honorary Secretary on the form prescribed, enclosing the necessary fees. Membership shall not become effective until confirmed by Committee.
- (c) A Member or an Associate Member may at any time resign his membership upon notification in writing to the Honorary Secretary. No membership fees are refundable upon resignation. Any such Member or Associate Member resigning shall nevertheless remain liable for and shall pay to the Association all monies which were due to the Association at the time of his resignation. Membership may be revived at any time upon application by the person concerned and upon payment of all arrears of subscriptions existing at the time of resignation.
 - (d) Membership shall cease or lapse upon written resignation served on the Honorary Secretary or automatically on nonpayment of any subscription which is more than twelve months in arrears.
- (e) Expulsion from membership may be effected upon a three-quarters majority of the votes of members present in person or represented by written proxy for that purpose, only at a General Meeting, provided that the notice convening such Meeting includes a statement of intention to submit a resolution for such an expulsion. Such a notice shall not be given unless the President is satisfied that the conduct of the Member or Associate Member in question falls within the category of criminal conviction and or gross misbehaviour of a public nature likely to bring the name of the Association into contempt, and then only on written requisition of not less than five members.
- (f) The Secretary shall maintain a register containing the names, addresses and other details of Members and Associate Members as determined by the Committee.
- SUBSCRIPTIONS 5. (a) Subscriptions shall be due on the first of January each calendar year.
 - (b) The annual subscription payable by each category of membership shall be determined at each Annual General Meeting on recommendation of the Executive Committee. If no

motion is passed at an Annual General Meeting setting dues, then they shall remain at the same rate or rates as during the preceding year.

- (c) A Member or Associate Member may commute his annual dues by becoming a Life Member of the Association by the payment of ten years' subscription in advance. Past membership subscriptions shall not count or be taken into consideration for the purpose of obtaining Life Membership.
- (d) Persons joining the Association before the 30th June shall pay the full subscription, while those joining after that date shall pay half the annual subscription.
- (e) Payment of a subscription may be remitted at the discretion of the Committee.

EXECUTIVE COMMITTEE AND OFFICE BEARERS

- 6.(a) The management and control of the Association's activities and its funds and property shall be vested in the Executive Committee, which shall exercise in relation thereto all the powers, rights and objects of the Association.
 - (b) The Executive Committee shall consist of the President, Deputy President, Honorary Secretary, Honorary Treasurer, Assistant Secretary, Editor of the Newsletter and five Committeemen.

 All members of the Committee shall be elected each year by a majority of the members present in person, or represented by written proxy, at the Annual General Meeting of the Association.
 - (c) The Office Bearers shall be the President, Deputy President, Honorary Secretary and Honorary Treasurer.
 - (d) Five Committee members, of whom one must be either the President or Deputy President, shall form a quorum at any meeting of the Committee and the presiding officer shall have a deliberative and casting vote.
 - (e) The Committee shall deal only with such matters as are included in the Agenda of the meeting, of which each Committee member received advance notice.
 - (f) The Committee shall meet at such times and places as may be determined. Meetings of the Committee shall be convened by the Honorary Secretary at the request of the President, or in his absence the Deputy President, or at the request of a majority of the Committee Members.

- (g) The Committee shall have authority to fill any vacancy that may occur on the Executive Committee between Annual General Meetings.
- (h) The Committee shall have authority to appoint delegates of the Association in States other than New South Wales.
- The Committee may co-opt additional members to join the Committee, until the next Annual General Meeting.
- (j) Associate Members may be elected to the Committee but must not in numbers exceed 30% of the total strength of the Committee.
- (k) The Committee shall have power to delegate (subject to such conditions as it thinks fit) any of its powers to subcommittees consisting of such members of the Committee and other members of the Association co-opted for that purpose as it may determine and to make such regulations as to the proceedings of such sub-committees as may be considered desirable.
- The Honorary Treasurer shall receive and handle all income of the Association and make all payments. The Honorary Treasurer shall keep such records (including cash book, receipts and payments, and membership lists showing details of financial status of members) as may be deemed necessary for the orderly management and recording of the Association's finances.
 - (b) The Honorary Treasurer shall prepare an Annual Financial Statement and Accounts, which shall truly reflect the financial position of the Association. The Association's audited Annual Accounts and Financial Statement shall be submitted for confirmation to the Annual General Meeting of each year.
 - (c) The Association's accounts shall be audited at least once a year by an Auditor appointed at the Annual General Meeting, or in the event of a vacancy occurring, by an Auditor appointed by the Committee. The person so appointed shall not hold any other office in the Association, but may be a member of the Association.
 - (d) All offices shall be honorary, and the funds of the Association shall be used only to defray the legitimate expenses of operating the Association.

(e) The funds of the Association shall be deposited with a recognised bank, building society or other financial institution, as determined by the Committee. All monies received shall be banked. The Office Bearers shall be signatories for withdrawals and cheques. Any two of the Office Bearers shall sign all cheques and withdrawals.

GENERAL MEETING

8. (a) The Annual General Meeting shall be held not later than the thirtieth day of April in each year. A notice convening such Meeting shall be posted to the registered addresses of each member and associate member at least fourteen days previous to the date set down for such a Meeting. Twenty members or associate members, of whom one must be the President or the Deputy President personally present, shall form a quorum at an Annual General Meeting.

SPECIAL GENERAL MEETINGS

- 9. (a) A Special General Meeting shall be convened by the Honorary Secretary on the authority of the President or Deputy President or on the requisition of not less than ten financial members or associate members of the association. Notice convening such a Meeting shall state the business to be dealt with, and shall be posted to the registered address of each member and associate member at least fourteen days previous to the date set down for such Meeting. Twenty members or associate members, of whom one must be either the President or Deputy President, personally present, shall form a quorum at General Meetings.
 - (b) No other business, except that listed in the notice convening that Meeting may be determined at a General Meeting.

VOTING

- 10. (a) Only financial members (as described in Clause 4(a)(1) shall be qualified to exercise a vote at any meeting of the Association.
 - (b) An Associate Member shall not be eligible to vote at Annual or Special General Meetings on any matter affecting superannuation or superannuants but otherwise shall be eligible to vote and submit resolutions.
 - (c) Voting at all meetings of members shall be by members present in person or represented by written proxy. Unless otherwise set out herein, all resolutions shall be declared carried if approved by a simple majority.

- (d) Voting shall be by a show of hands unless a ballot is called for.
- (e) In the event of equality of votes a resolution shall be declared lost.
- (f) A member may appoint a proxy for any meeting. The Chairman of the Meeting or any other member may be appointed as proxy. Such appointment of a proxy must be signed by the member making the appointment and his signature must be witnessed. A proxy shall be valid only for the Meeting specified in the appointment.
- PATRONS 10A. (a) The Association may, at an Annual or Special General Meeting, appoint one or more patrons.
- AMENDMENT 11. (a) This constitution may be amended or repealed only by a three-fourths majority of votes of members present in person or represented by proxy at an Annual or Special General Meeting of members and only after due notice of such intention has been given to members, as set out in Clauses 8 and 9 above.
- DISSOLUTION.12. (a) The income and property of the Association whencesoever derived shall be applied solely towards the promotion of the objects of the Association as set forth in this Constitution, and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever by way of profit to the members of the Association provided that nothing herein shall prevent the payment in good faith of remuneration to any officers or servants of the Association or to any member of the Association or its members, nor prevent the payment of reasonable and proper rent for premises demised or let by any member to the Association.
 - (b) If upon the winding up or dissolution of the Association there remains after the satisfaction of all its debts and liabilities any property whatsoever, the same shall not be paid to or distributed among the members of the Association, but shall be given or transferred to some other association, institution or institutions having objects similar to the objects of the Association and which shall prohibit the distribution of its or their income and property among its or their members to an extent at least

as great as is imposed on the Association under or by virtue of this Constitution. Such association, institution or institutions to be determined by the members of the Association at or before the time of dissolution.
