Dear Member--

Greetings and salutations to all readers -- I hope you are all happy, wealthy and well prepared for winter - or for summer for our European members! Don't worry, I know it's not Christmas nor my birthday - I just wanted to say hello!

Consumer Price Indexation. The rise in the C.P.I. for March was 2%, making a total of 9.4% from 1 April 1986 to 31 March 1987, the period on which any rise in our superannuation is based. This means that your superannuation as from July 1987 should rise by 9.4%. We do not think that the new Government will repeat last year's mistake and discount the rise this year - but one never can be sure.

Donations. A total of \$210 has been received since 1 January over and above the usual subscriptions. Your Committee is very grateful, especially to the Life Members who have sent in further contributions as technically they are paid up. Although our investments produce income this is taxed (!!!) and we are largely dependent on subscription income, so any extra really does help.

\* \* \*

Learn from the mistakes of others - life is not long enough for you to make them all yourself.

Latest news on the Discounting of our C.P.I adjustment:

The Government reduced our superannuation pension by 2% last October. The efforts of the Superannuated Commonwealth Officers Association, the Regular Defence Force Welfare Association and this Association, strongly supported by Sir William Keys, National President of the R.S.L., have persuaded the Government to rethink it's policy. For this turnabout we also have to thank those individual members of these Associations who helped by sending letters to parliamentarians complaining about the discounting

We believe that superannuitants will receive the full 9.4% C.P.I. increase as from 1st July and we do not expect that there will be any discounting of this increase - but again let's wait for the August Budget.

The Government has accepted the principle that the effect of the pension discounting should be limited to 1986/87 and not be perpetual, but believes it would be premature to do so immediately. "However I should emphasise that as economic conditions permit, the Government will legislate to restore pension levels " -- Lionel Bowen, Minister Assisting the Prime Minister.

Your Committee will not be satisfied until our pensions are restored.

Taxation

We had intended publishing details of the Government's proposed tax reforms BUT as there's an election on who knows which party will be in power after July 11? In any case there's the Budget in August which may bring another change. To avoid any confusion it seems better to hold our tax segment until later.

MINUTES OF 36TH ANNUAL GENERAL MEETING  
HELD AT NEW TAI YUEN RESTAURANT ON 29 MARCH 1987

Meeting opened at 11.15 a.m. with 72 members present.

Apologies:

Minutes of the 35th AGM having been published and circulated to members it was moved by Mr West, seconded by Mr Burfoot that they be accepted.  
(Matters arising from the Minutes were dealt with later).

The President gave his report -- as follows:

"The past year has been one of great uncertainty. There has been a significant deterioration in the economy, with the consequent fall in the Aussie Dollar, high interest rates and a decline in our standard of living. With respect to our political situation, I think the least said the better.

This does not auger well for the majority of us here today who are superannuitants. Our incomes are predetermined and there is very little we ourselves can do about them. We have, however, in recent years been protected by legislation and its value has to a great extent been maintained because each year it has been indexed in keeping with increases in the cost of living.

Therefore it came as a very rude shock last year when in the last Commonwealth Budget there was an erosion of these benefits with the current government discounting by 2% the cost of living increases due to us. This subject is an agenda item for later in the meeting and at this stage all I want to say is that your Committee has worked very hard during the past year to protect your interests in this and other matters. I thank all the members of the Committee for their co-operation and hard work on your behalf during the year.

I regret to report that last August Gabriel Keleny resigned as Treasurer because of eyesight problems. During his term of office Gabriel fulfilled his role in a most dedicated, effective and efficient manner. In fact, our stable financial situation is in a large measure due to Gabriel's untiring efforts. Bill Johnston took over from Gabriel as Treasurer and has very ably carried on the good work.

One of the most important duties of your Committee, I am sure you will all agree, is the production and despatch to all our members the Association Newsletter, Una Voce. The person wholly responsible for this task over the past eight years has been Les Clout, very ably assisted by his wife Doreen. A great deal of time and effort is involved in producing Una Voce and Les has always performed this task most efficiently on schedule. He and Doreen are now overseas and I would like placed on record our deep appreciation of their great work.

Whilst I am dealing with Una Voce - a newsletter, irrespective of how well it is produced, is no good unless the content is pertinent and of interest to our members. The person responsible for this side of the operation over recent years, as you would all know, has been Fred Kaad. Fred has continued with the good work and very effectively carried out his duties as Editor during the past year. Fred has an Editorial Committee consisting of Bill Kelly and Bob Pulsford and I would like to thank them for the excellent work they have performed. The person who keeps Freddie on his toes, does all his typing and works hard to see that he meets deadlines is our very efficient Assistant Secretary, Mrs Pamela Foley. She also does all the Association typing, production of Minutes etc. and carries out a myriad of administrative tasks in assisting our Secretary, Harry West, with the administration of the Association. Pam is also a member of our Social Committee. I don't know how we would get on without her, so many many thanks Pamela for all your efforts.

Our Secretary, Harry West, has continued to work tirelessly during the year in carrying out his duties and I regret to report that he will be standing down as Secretary, but would like to continue on the Committee. Harry has, in addition, been responsible for organising our social functions as Chairman of our Social Committee and in this work he has been very ably assisted by Chris Downie, Pam Foley and Roma Bates. Many thanks Harry for all your efforts on our behalf and thanks to your Social Committee for their good work.

The work of another committee very much appreciated by our members, particularly those who are sick, lonely or bereaved, is that of the Keep in Touch or Caring Committee. During the year this work has been very caringly performed by Mrs Candy Parrish assisted by Dave Marsh, Christina Grant and Joe Nitsche. 35 members and associate members were contacted by the committee. Cards were sent in the case of sickness and grief and to some of our elderly for Christmas and birthdays. Visits were also made to some of our members who were sick in hospital. This Committee, however, cannot be fully effective unless members generally let the committee know the names of members who are sick, lonely or in grief so that the committee can contact them. Great work Candy and helpers.

Another committee which must be commended for its work is the Membership Committee under the direction of Geoff Burfoot assisted by Marcia Lightfoot and Jim Rudge. A membership drive during the year resulted in the Association gaining some forty new members. Excellent work folks!

Geoff, unfortunately for us, is moving north to take up residence near Tyalgum in the Tweed area. We wish him well and hope that he enjoys his new home. He does not know it yet, but he is going to be appointed as our representative on the far north coast where a number of our members are located. He does not get away from us that easily!

The last of our committees, the Legal and Administrative Committee, for which I have been responsible assisted by Dr. Stan Wigley and Bill Johnston, has devised and implemented a new application form and dealt with any legal matters raised by members.

I would now like to place on record our great appreciation of the fine gesture by Air Niugini, through our very good friend Brian Costello, in donating to the Association two airfares Sydney/Papua New Guinea/Sydney for use by the Association in a manner it saw fit. You will remember we asked our members through Una Voce for suggestions as to how these tickets should be allocated. The Committee finally decided that they should be given to two university students writing theses on PNG topics. The students have been to Papua New Guinea and they have written and told us that their visits were most worthwhile and assisted them greatly in their work. Many thanks to you, Brian Costello, and to Air Niugini for making this exercise possible.

I now regret to advise that we have a problem which I hope some member will help us resolve. Les Clout, because he and his wife contemplate doing a lot more travel, is unable to continue with the production of Una Voce and we would be most grateful if someone could undertake this task. Please let me know if anyone is interested.

It is most unfortunate that we have had to change our venue for this meeting and luncheon. The Mandarin Club is no longer catering for functions on a Sunday and we received very short notice of their change in policy, hence the current venue. The Committee is searching for a new, and hopefully, a permanent venue for our functions but this is proving a most difficult task. Because of the very high penalty rates prevailing for weekend work in restaurants and clubs, it is very hard to find a suitable venue at a reasonable price. We shall keep searching!

Finally, I believe it has been another successful year for the Association and I wish the incoming Committee every success in its endeavours.

The President then resumed the chair and reported on the 2% discounting of pensions. The Association had contacted other groups affected by the discounting i.e. the Commonwealth Superannuated Officers Association and the Regular Defence Force Welfare Association, and was working in cooperation with them. Mr Parrish said he had had discussions with individual Members of the House of Representatives and had been advised that the best time for presentation of protests would be late March or early April. Possibly a deputation could be formed to approach the Minister for Finance.

Letters from the Association had been sent to the Prime Minister, the Treasurer and the leader of the Liberals, the Country Party and the Democrats. Individual Committee members had written to their Members in the Senate and House of Representatives.

Letters from the Minister for Finance in reply to that sent from this Assocn, also to and from S.C.O.A, were also read to the Meeting.

The President said that the gist of letters received from Parliamentarians was that it was felt that superannuitants had fared better in recent years than some other bodies. The consensus seemed to be "Times were hard". He regretted not having better results to report, but assured the meeting that the Committee would continue to press on.

Mr Williams commended the authors of the letters sent on behalf of the Association - but felt the Government was not likely to alter its position..

Mr Parrish said that the many members who had taken the Association's advice and written to their parliamentarians should be thanked for their efforts.

#### General Business

Mr Speer urged that Mr Doug Joyce's publication "Recollections" be reviewed in the near future. The President agreed, paid tribute to Mr Joyce for his long service to Papua New Guinea and said that the book would be reviewed.

Mr West advised that Mr Aitchison will not be available for the position of Hon. Auditor after the end of 1987.

Discussion followed on finding an alternative time and venue for the AGM. Members were asked to forward suggestions.

New Member Nan Watkins was welcomed to the meeting, also visitor Mrs Janet Robertson who had accompanied her mother, Mrs Mona Normoyle.

There being no further business the Meeting closed at 12.38 p.m.

Sir Peta Simogun

Most in the Association will know the post-war work in political and economic development carried out by this great Papua New Guinean. The following letter to the South Pacific Post is printed as a tribute to his wartime work:

"On behalf of a group of Australians, I would like to record our high regard for, and express our appreciation of, Sir Peta Simogun who died recently.

I first met Sir Peta in 1935 when, as a lance-corporal of police, he was assigned to my patrol to re-open the post in Central Nakanai, New Britain. We became friends and I was aware even then of the great potential of this man. His influence with the local people was, from the start, very strong and although, as a Sepik man, he was a stranger, their acceptance of him as a friend and adviser was quick. He was promoted to corporal on my recommendation.

In 1943 I was in Port Moresby forming a party to carry out coastwatching operations on the south coast of New Britain which was then occupied by Japanese forces in strength. The purpose was to cover air and sea movement to the south-west of Rabaul. Leslie Williams and Peter Figgis, both A.I.F. officers, had joined my party and when I heard that Sergeant Simogun was at the R.P.C. training depot at Hanuabada, I approached him with A.N.G.A.U. approval. He immediately agreed to go with us and in reply to my saying that there was a risk of our being killed, he responded in those now well-known words, "Mi dai, mi dai. Mi got pikininni man belong karim nem belong mi."

With three more New Guinea men, all from New Britain, we landed from a U.S. submarine at Baien on the night of 30th April 1943, and immediately began moving our equipment and six months' supplies into the bush. Not wishing to involve the beach people in the event of Japanese inquiries, we carried our own cargo, the great bulk of it by Sergeant Simogun. With the assistance of some bush people we built a post overlooking the coast. In these very difficult times, Sergeant Simogun's personality never flagged and he inspired everyone with his energy and optimism.

In October 1943 after receiving reinforcements by submarine, Leslie Williams, Lou Searle, Sergeant Simogun and Sergeant Marsh and I, with three New Guinea men recruited locally, moved across New Britain in a very difficult march to take up a new position in Central Nakanai. In this operation Paramount Luluai Golpaik of Pomio was superb in his organisation of the carriers and warning of the approach of Japanese patrols in the area. Our welcome by the Nakanai people was tremendous and Simogun in particular was received with enthusiasm and a great show of friendship.



As the Allies moved towards Rabaul, our coastwatching functions were reduced and G.H.Q. approved our operating as guerillas against the Japanese troops retreating towards Rabaul. There was an indication that the hungry forces would move into the huge food area in the Central Nakanai mountains. We armed 200 Nakanai men with rifles and shotguns and after a short course in handling the weapons from Lou Searle and (now) Sergeant Major Simogun they began attacking the retreating enemy. Simogun was in command of the main group and his courage, tactics and great leadership brought them immediate success. In less than two months the Nakanai groups killed 256 Japanese and wounded many more; two Nakanai men were lost. Sergeant Major Simogun's personal score was 31.

In April 1944 we were relieved and Les Williams, Sergeant Major Simogun and I with twelve Nakanai men were taken off the beach by U.S.P.T. boats and the entire party brought to Australia. For his services in New Britain Simogun was awarded the British Empire Medal.

After the war Simogun served in the R.P.N.G. Constabulary for a short time then he saw the possibility of development among his own people and worked with them. His influence, ability and reputation became widely known and so great that he was selected by the Minister for Territories to be one of the three indigenous members in the new Legislative Council. His career from then on is well known and his knighthood was an honourable and fitting recognition of his work. After meeting in PNG Lord Casey, the Governor General of Australia, described him to me as "a man of consequence".

Leslie Williams, Peter Figgis, Lou Searle and I wish to record our high regard for this great New Guinean, great man and great friend.
